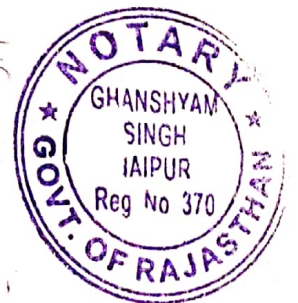

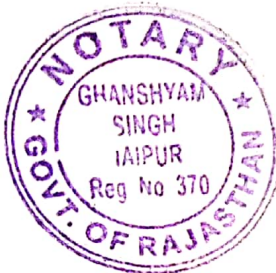


RESOLUTION


